GENERAL INFORMATION

The Ellensburg Rodeo Royal Court will consist of two members one queen and one princess. The Royal Court will act as ambassadors on behalf of the Ellensburg Rodeo for the entire reigning year (coronation date to coronation date). The Royal Court spends the year traveling and attending local, state and out of state events to promote and advertise the Ellensburg Rodeo. The schedule of the Royal Court will be ever changing with events but mostly likely the Royal Court will be busy every weekend starting towards the end of April until after Labor Day Weekend. If chosen as a member of the Ellensburg Rodeo Royal Court, you will need to comply with the Court Contract, Eligibility Requirements and Royal Court Handbook (all are provided on www.ellensburgrodeo.com) so please read them thoroughly.

It is an honor to be chosen to represent the Ellensburg Rodeo. It is the desire of the Rodeo Board to be helpful in explaining to the ladies and their parents what is expected of them if chosen as a member of the Royal Court. Please review all pieces of the application to fully understand the capacity of this role. If you or your parents do not feel you can give 100% toward the Royal Court functions and the public relations duties involved, please do not sign, and return this form.

Each Royal Court Contestant will need to gather contributors for the Ellensburg Rodeo Royal Court program. This portion of the pageant does not count towards being selected to be on the Royal Court and a separate award will be given to the contestant with the largest overall contributions to the program. Each contestant needs to bring in a minimum of \$500. Information about contributors will be covered in the pageant information given at the initial meeting.

The pageant has moved all parts of the competition to happen in the same weekend which will be the last Friday and Saturday of January 2023. The schedule is above for reference, but more specific times and locations will be given out at the initial meeting. The pageant will continue with the past dress code of for horsemanship with a white button down long-sleeve shirt, dark blue Wrangler q-babies, black boots, black hat, black belt and coronation an outfit that follows the current Western trends. Another new aspect of the pageant will be a personally decorated denim button down long-sleeve shirt for personal interviews. All the information about dress code will be given out at the first initial meeting. At the first initial meeting we ask all contestants to dress in appropriate street clothing.

The Ellensburg Rodeo Royal Court Director has the authority to make provisions and waive eligibility rules and/or regulation requirements with the approval of the Ellensburg Rodeo Board of Directors.

All Contestants shall agree to abide by all of the rules and regulations set forth by Ellensburg Rodeo Executive Board. Failing to meet any of the eligibility rules (without a waiver) will disqualify a contestant from the competition.

Contestant Eligibility: Each Contestant in the Ellensburg Rodeo Royal Court Pageant on the date on the signature line until the final selection of Ellensburg Rodeo Royal Court shall acknowledge these eligibility requirements. **(Please initial each numbered item below, confirming that you have read, understood and will abide by these rules and regulations.)**

1. **Age:** Must have at least obtained the age of 18 years and shall not have obtained the age of 22 by August 20th of title year. Copy of current and valid WA state Driver’s License is required and must accompany the contestant application. Driver’s License must be valid and current during the entire pageant period (date application is due until coronation). If selected onto the Royal Court, Driver’s License must be valid and current for the reigning year. **Initials** _____

2. **Residency:** Must be a US citizen and resident of Kittitas County for a minimum of one complete year. To be considered a resident you must have your main address, the place you call home, be within Kittitas County. Your residency is the official place you reside your time. In regards to girls attending college out of county it will be at the discretion of the Royal Court Director. Verification may be requested. **Initials** _____

3. **Rules and Regulations:** Shall abide by all rules and regulations of the Ellensburg Rodeo Royal Court Pageant. All rules and regulations will be attached to the eligibility requirements. **Initials** _____

4. **Education:** Have obtained a high school diploma or equivalent or must be currently enrolled in high school. Applicant must provide, along with the application a sealed, official copy of the most recent grade transcripts, and must have minimum accumulative 2.5 G.P.A. Applicant must maintain a minimum accumulative 2.5 G.P.A. from the date the eligibility form was signed through the entire reigning year, if selected. From time to time, the Royal Court Director may ask for a sealed, official copy of most recent grade transcripts. A sealed, official copy of the most recent grade transcripts will also be required before payment of scholarship can be fulfilled.

5. **Scholarship:** The Rodeo Board will award the reigning Ellensburg Rodeo Queen a \$3,000 and

princess a \$2,000 academic scholarship, providing they are accepted and enrolled in a state university, community college, or accredited trade school upon completion of her reign. The scholarship will be paid to the university, community college, or accredited trade school upon notification of meeting entrance and attendance requirements. You have one year after completing your reign to claim your scholarship. To claim your scholarship, you must provide the Ellensburg Rodeo office with the proper information:

- a. Full Name
- b. Student ID Number
- c. School Name
- d. Financial Aid Office address
- e. Official sealed transcript

If you are pursuing another type of education, please indicate the education path have chosen to the Royal Court Director to allow them to handle it at their discretion. **Initials** _____

6. **Gender:** I am a natural born female. **Initials** _____

7. **Marital Status:** Titleholder may have a boyfriend during her year. However, the titleholder will not enter into a public dating relationship during her reign. This includes no taking or posting of photographs with the titleholder's significant other and no public displays of affection. I am not currently married and have never been married. I agree that I am not engaged to be married, nor will I become publicly engaged to be married during the course of my reign. **Initials** _____

8. **Parental Status:** I am not the parent or legal guardian of any child and have never been pregnant, nor will I become pregnant during the contractual time frame of the Ellensburg Rodeo Royal Court contract. **Initials** _____

9. **Good Character:** I have never committed or been involved in an act of moral turpitude. Must previously and presently, portray high moral standards and a superb ethical character. **Initials** _____

15. **Contractual Obligations:** I am not under any contractual obligation which would interfere with my ability to participate in this contest or interfere with my ability to perform as Ellensburg Rodeo Royal Court, if selected. I agree to provide copies of any and all contracts to which I am a party if requested by the Ellensburg Rodeo. **Initials** _____

16. **No Other Competitions:** I do not hold any other current title in any pageant of any kind which would prevent me from fulfilling the duties of the Ellensburg Rodeo Royal Court, if selected. I will not obtain any other title until after my reigning year is completed the following January. It is at the Director's discretion to allow court members to compete for other titles in occasions where the title would not infringe on the duties required of the Royal Court.

18. **No Agent Status:** I will not incur any bill, obligation or liability on behalf of the Ellensburg Rodeo. **Initials** _____

19. **Removal of Titles or Rejected Pageant Applications:** I have not had a queen/princess or similar title removed for any reason, nor have I had a pageant application rejected after submission. If applicable, contestant may request a hearing for review. **Initials** _____

20. **Ability to Perform:** To the best of my knowledge, there is nothing that will interfere with my ability to compete in this contest or to perform the obligations of Ellensburg Royal Court, if selected. Royal Court duties will come first throughout the reign: before work, vacation, school, etc. Some activities may be added to the schedule on very short notice. If I have any concerns about the applicability of and of these provisions, I acknowledge I have been advised to discuss this with the Ellensburg Rodeo Royal Court Director. **Initials** _____

21. **Social Media:** We expect you to, and you agree to, conduct yourself at all times in a way that is consistent with the high standards and ideals of the Ellensburg Rodeo, and of your community in general, as determined by the Ellensburg Rodeo and by its Board of Directors, based solely upon the exercise of their discretion. Specifically, but without limitation, you agree:

- a. Any and all social media activity is clean, appropriate and consistent with the high

standards and ideals of the Ellensburg Rodeo. This includes both public and private accounts.

- b. The Rodeo has full knowledge and access to all social media accounts created by you.
- c. All fake social media accounts created to post inappropriate content privately must be taken down and deleted permanently.
- d. Any and all social media content that tags you or includes you that violates the high standards and ideal of the Ellensburg Rodeo must be taken down immediately. This includes inappropriate posts and photos you are tagged in or mentioned in on all social media platforms.
- e. It is at the Ellensburg Rodeo's discretion to fully prohibit any use or form of social media during the duration of the pageant and reigning year if selected for the Royal Court.

22. **Horse:** I am able to furnish a suitable horse that measures 14.2 to 16 hands. The horse will not be a stallion. The selected horse should be well mannered, clean at all times, well-groomed and shod. I am able to ride the horse in safe and controlled manner at a walk, trot, lope and full run (wall run speed). The Royal Court Director will determine if the horse, equipment, and rider's capabilities are acceptable. The Royal Court Director will determine if the horse and equipment are acceptable. If not, I am willing to ride a mount and provide equipment that qualifies. It is encouraged that the applicant uses the same horse, during the riding competition, that they intend to use the rest of the season if selected. If the horse being used during the competition is borrowed and will not be available for use the rest of the year, the Royal Court Director will need to know before the riding competition. **Initials** _____

23. **Consents and Waiver:** I acknowledge I must execute all required documents as set forth in the application packet, consents and/or waivers of liability presented as conditions by application deadline. If at any time I or my parents refuse to carry full responsibility of the Royal Court duties, I understand I will be terminated and all clothing, chaps, buckle, crown and tack must be returned to the Rodeo Office. **Initials** _____

24. **Royal Court Contract and Handbook:** I have read and acknowledge the Royal Court Contract and Handbook. I agree to withhold all rules and expectations laid out in the contract and handbook if selected for the Royal Court.

25. **Disciplinary Action:** A representative of the Royal Court is always expected to conduct herself as a professional during the contest and is expected to comply with the Eligibility Requirements, the Pageant Rules and Regulations, and the Royal Court Handbook. This includes all behavior and activities from the time she enters the Ellensburg Rodeo Royal Court Pageant, until if selected for the Royal Court, she relinquishes her reign. During the term of this agreement, the following will be the disciplinary actions for misconduct.

- a. **First Warning:** Will be in verbal form and documented by the Director of the Ellensburg Rodeo Royal Court.

- b. Second Warning: Will be in written form and signed by the Representative and the Director of the Ellensburg Rodeo Royal Court to signify receipt of warning.
- c. Third Warning: Will be in written form, from the Director of the Royal Court and the President of the Ellensburg Rodeo Board. The action for the misconduct is under the sole discretion of the Director of the Royal Court and President of the Rodeo Board. If the Disciplinary action results in termination the Royal Court Representative will relinquish title, crown and all awards.

The warning does not have to be the same offence.

Any member of the Royal Court that displays behavior not consistent with the Ellensburg Rodeo standards as given in the Eligibility Requirements, the Pageant Rules and Regulations, and the Royal Court Handbook, as determined in the sole discretion of the Rodeo Board of Directors, will be subject to such disciplinary action as the Rodeo Board of Directors deems appropriate, including without limitation removal as a member of the Royal Court. You understand and agree that if you are removed as a member of the Royal Court, you will lose all of the rights, privileges, and Ellensburg Rodeo property associated with that honor. You also agree to hold harmless the Ellensburg Rodeo, and its Board of Directors, from any claims you may have as a result of removal, or other disciplinary action. Initials _____
